New Business - discussion

- A nice letter was received from a family in regards to the safety skills their children gained at the hunter safety class the club sponsored earlier this year. They put the skills into action turkey hunting this spring.
- Reminder to everyone helping with High School league rounds, make sure to fill each Trap house with 15 cases of clays after your done shooting.
- A few folks have noticed the throwers are getting jammed up a bit more than usual with dust-chips from clay targets. Karl and Chad have volunteered to "blow out" the machines.
- Grass is growing and will be cut and trimmed as needed, in advance of Sundays if possible. A 2 round punch card will be made available to the person doing the work. Current blades need to be sharpened. A second set will be purchased then can alternate sets while sharpening. Will work on applying weed killer for the dandelions (Troy). Also do some total kill around the edges of buildings, polls, etc, to reduce the amount of trimming needed (Bob L).
- Additional "No Parking" signs have been posted to help open up the driving lane near the club house.
- Desire to post "Slow Down" signs near the parking entrance.

New Business - action
