

ARTICLES OF INCORPORATION

OF

We, the undersigned, for the purpose of forming a corporation under and pursuant to the provisions of Chapter 317 Minnesota Statutes, known as the Minnesota Nonprofit Corporation Act, do hereby associate ourselves together as a body corporate and adopt the following Articles of Incorporation:

ARTICLE I.

The name of this corporation shall be MORRISTOWN GUN CLUB, INC.

ARTICLE II.

The purpose of this corporation shall be to promote the hobby and art of trap and skeet shooting, rifle and pistol marksmanship, and to encourage proficiency and skill therein; to influence the proper protection of game and proper laws therefor; to foster good fellowship among sportsmen; to support and teach gun safety in all respects; to defend the right of the individual to have and keep arms for his own protection and that of his home and family, and generally to do all things incidental and necessary to accomplish these purposes.

ARTICLE III.

This Corporation shall not afford pecuniary gain, incidentally or otherwise, to its members.

ARTICLE IV.

The period of duration of corporate existence of this corporation shall be perpetual.

ARTICLE V.

The location of the registered office of this Corporation in this state is Morristown, Minnesota.

ARTICLE VI.
