Who: All kids 6th through 12th grade.

When: May 24th through July 19th, Thursdays 5:00pm to dark or Sundays, 11:00 am to 2:00 pm. Please check the Morristown Gun Club website as the schedule does change based on events at the club before coming. www.morristowngunclub.com

Cost: \$75.00 includes a punch card of 10 rounds of 25 clay targets, Invite to Championship Shoot Day/picnic. Includes clay targets for the championship round. **Cost does not include ammunition**.

Format: Athletes will be assigned a division based on their most recent complete seasons average of Varsity (19-25), JV (15-18.99), and Novice (0-14.99). If the athlete does not have an average, then they must compete in novice category. This is a non-school sanctioned league, but we would encourage you to wear your team colors. We would also encourage you to compete with athletes from different schools so you can get a chance to meet some of your fellow athletes and hopefully bring home the bragging rights to your school by finishing in the top of your division. Competition will be first come first serve at your convenience for the league competition. You may shoot as many rounds as you desire on any given day until your 10 rounds are complete. You must announce at the club house if your round is for league play or practice before you shoot. You must use your punch card for competition, practice rounds must be purchased separately. We will squad kids accordingly when possible so "like" athletes are shooting together. We will attempt to make full squads when ever possible so you may need to wait until a squad fills up. At the end of season (July 19th) the highest 10 averages for each division will compete for the top three places in each division where trophies will be awarded. This is tentatively scheduled for Saturday July 25th. Ties will require a shoot off format until a winner is determined. There will be Food and door prizes for all registered athletes that attend the event regardless of participation.

How to participate: Please fill out the athlete participation form and email back to morristowngunclub@gmail.com. Please bring cash or check to the Morristown Gun Club on or before your first competition round. The front desk staff will check you off and mark you down as paid. They will give you a "Competition" punch card. All practice rounds must be purchased separately or stop by Morristown Gun Club with money & form on Thursday or Sundays any time before the May 24th while the Club is open. Please check the Morristown Gun Club website for times and days the club is open before coming as the schedule can change due to other events happening at the club.

Remember to Practice Safe Gun Handling at All Times!

All shooters must have a signed wavier and release on file prior to participating in any Morristown Gun Club shooting activity. Down below or complete at the club.

- 7 1/2 or 8 shot only.
- Must always obey range master.
- Ear and eye protection strongly recommended. (required for minors)
- Keep action open when not on station.
- · Keep muzzle pointed down range.
- Load gun only on station.
- Load only one shell at a time (two for doubles and wobble).
- Unload gun when flag is visible or moving between stations.
- Pick up your empty shells at end of round.
- No Illegal substances.
- No alcohol before or while shooting.
- No rifles or pistols allowed.
- · Be respectful of other club members while competing.

*Covid 19 protocol in effect. Please be mindful of a 6' social distancing policy inside and out on the range as well. Use west window as option to purchase rounds or refreshments. If you choose to come in the club house please do not congregate inside, make your purchase and exit the clubhouse and wait outside for your round to begin. Come prepared with your own personal protection if you desire. If you have a fever or are not feeling well or have been in contact with someone who has been diagnosed with Covid 19, please do not come to the club until 14 days have passed or you have been cleared by a physician.

WAIVER AND RELEASE AGREEMENT

This is a release of liability and waiver of certain legal rights.

- 5. Inclement weather conditions.

I understand the risks, hazards, and dangers of the use of fire arms and have had the opportunity to discuss them with Morristown Gun Club. I understand that these activities may require good physical conditioning and a degree of skill and knowledge. I believe I have that good physical conditioning and the degree of skill and knowledge necessary for me to engage in these activities safely. I understand that I have responsibilities. My participation in this activity is purely voluntary. No one is forcing me to participate and I elect to participate in spite of the risks. I am voluntarily using the services of Morristown Gun Club. WILL FULL KNOWLEDGE OF THE INHERENT RISKS, HAZARDS, AND DANGERS INVOLVED AND HEREBY ASSUME AND ACCEPT ANY AND ALL RISKS OF INJURY, PARALYSIS, OR DEATH.

Lastly, I, for myself, my heirs, successors, executors, and subrogates, hereby KNOWINGLY AND INTENTIONALLY WAIVE AND RELEASE, INDEMNIFY AND HOLD HARMLESS, Morristown Gun Club, their directors, officers, agents, employees, and volunteers from and against and all claims, actions, causes of action, liabilities, suits, expenses (including reasonable attorney's fees(which are related to, arising out of, or are in nature, whether foreseen or unforeseen, arising directly or indirectly out of any damage, loss, injury, paralysis, or death to me or my property as a result of my engaging in these activities or the use of these services, animas or equipment, whether such damage loss, injury, paralysis, or death results from negligence of Morristown Gun Club, or from some other cause.
